Each new academic year in the United States is accompanied by enrollment in the universities of the countries of a large number of visiting students. This is not surprising, because the education system in this country is considered one of the highest quality, and educational institutions are known worldwide. For legal location in the United States during training you need to get a Visa F1. Student visa in the United States gives the curricula of its owner, and also gives it certain rights. You can study on the proposed programs to all who have a level of knowledge of the English language is at least initial. Before enrollment, the university will be invited to pass testing using a computer that will determine the level of knowledge of the language. In accordance with the results of the test, the applicant will receive a referral to a specific group, where training will be carried out.

A person who has a learning status will have to study 18 hours a week, that is, such a period must be a couple at the university. This rule is prohibited to violate, because, otherwise, a visa in the United States may be canceled, and the status of the study will switch to illegal, which means deportation from the country. This is followed by specially hired people who convey collected data on attendance in the immigration service. Not more than 30% of passes from the total number of classes are allowed.

It is necessary to understand that it is categorically prohibited to engage in labor activities in addition to studying at home. Work is allowed on the campus territory, but this must be clarified separately. You can work for no more than 20 hours a week and only after a year of study at the university. Official work with such a visa is not possible. In very rare cases, it is possible to work with the US student visa, if problems with finance are found, without which it will be problematic in the States. In this case, an appeal to the immigration service is allowed. Do not forget that there is a lot of part-time jobs for cash, where special permission is not required.

The transfer is called a change of educational institution. It is noteworthy that it is not necessary to start study at all. Legislation allows for the country for two months, which makes it possible to save money that would go to pay for this period of study. The most important thing is to receive the I-20 certificate from the past educational institution. Pluses of a student visa in the USA

Visa for studies in the United States is available to all people who have age from 18 to 40 years. The learning status allows you to freely move throughout the country, as well as leave it, which makes it possible to go home during the holidays.

The student has the right to change the educational institution for any other at its discretion.

There is an opportunity to get another status of a citizen of the country, and at any time.

Extending the term in the country is also allowed. In some situations, this time segment can be up to 6 years, and sometimes more.

The opening of a student visa in the United States is accompanied by some special moments, among which the student's financial support is allocated and much more. It is recommended to apply to visa centers or similar organizations that will provide all the information you are interested in and will help get a F1 visa in the fastest time.
